Long Term Disability Benefit Summary

Group Long Term Disability insurance through the PSET program, underwritten by Standard Insurance Company (The Standard), helps provide financial protection for insured members by promising to pay a monthly benefit in the event of a covered disability.

Eligibility

Definition of a Member:

Regular employee of Karr Tuttle Campbell, actively working at least 30 hours per week, and a citizen or resident of the United States or Canada. You are not a member if you are a temporary or seasonal employee, a full-time member of the armed forces, a leased employee or an independent contractor.

Class Definition:

Class 1: Attorneys, Human Resource Director, Chief Financial Officer, and Director of Information Technology

Class 2: All other Members

Eligibility Waiting Period:

You are eligible on the first of the month following 60 consecutive days as a Member.

Definition of Disability

All Classes:

For the benefit waiting period and to the end of the maximum benefit period that Long Term Disability benefits are payable, you will be considered disabled if, as a result of physical disease, injury, pregnancy or mental disorder:

- You are unable to perform with reasonable continuity the material duties of your own occupation, or
- You suffer a loss of at least 20 percent of your Predisability Earnings when working in your own occupation.

You are not considered disabled merely because your right to perform your own occupation is restricted, including a restriction or loss of license.

Benefits

Monthly Benefit:

Class 1: 60% of your monthly Predisability Earnings, reduced by Deductible Income, up to the maximum monthly benefit of \$20,000.

Class 2: 60% of your monthly Predisability Earnings, reduced by Deductible Income, up to the maximum monthly benefit of \$10,000.

Benefit Waiting Period:

90 days

If a claim for Long Term Disability benefits is approved, benefits become payable after the member has been continuously disabled for 90 days.

Maximum Benefit Period:

Up to the Social Security Normal Retirement Age (SSNRA). See policy certificate for details.
